The Appointor has ultimate control (namely, can appoint and discharge the Trustee). Depending on the individual circumstances of the client, the Appointor can be a single person or two persons jointly (eg: husband and wife).

The deed provides that the beneficiaries include such persons as are related to the Principal Beneficiary as follows:

The spouse, children and remote descendants of such children, brothers, sisters parents, children and remote descendants of such brothers and sisters and spouses of any of the foregoing.

Generally, the Principal Beneficiary would be the husband, the wife or both the husband and wife. The latter is recommended where there are children of previous marriages. Note also that the beneficiaries include companies and trusts associated with all the persons named.
